Course Objectives:

This start-up foundation program in Accounting aims for amateurs to their basic skills in accounting and lays a solid foundation on accounting concepts to embark on a semi-professional accounting career or to further their study. The program provides the first step for you to get into the accounting field.

Program Structure:

The Foundation Diploma in Accounting offered and awarded by ABRS will consist of 3 modules. The program will equip students with sufficient knowledge on basic financial and cost accounting. Students will find the program highly practical with enough academic background to proceed to next level. Students who completed the program can attempt LCCI Intermediate / Higher Accounting papers and can also apply for HKIAAT exemption.

The Foundation Diploma in Accounting will last from 3 to 5 months depending on your entry qualifications / pace of schedule. The total duration of the program is over 80+ face-to-face lectures hours, assignment and a 1 to 3-hours examination per module. The Foundation Diploma offers by ABRS lead to a maximum of 2 subject exemptions in our Diploma in Accounting and Finance program upon successful completion. HKIAAT Paper P1 exemption is undergone the process of accreditation. To qualify for the HKIAAT exemption, students need to complete our foundation diploma together with scoring 60 marks or above in the programme modules corresponding to HKIAAT examination papers. Students should take note that programme modules exempted on the basis of their past academic achievements will not be qualified for HKIAAT exemption.

Open Entry preferable with Form 5 level or above,

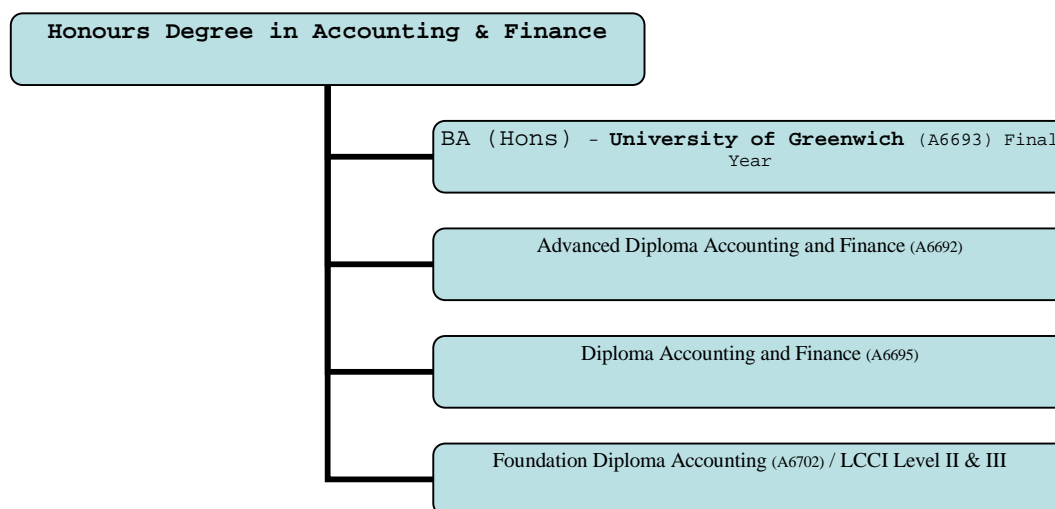
